DURING 2019, THE PSPCA FOUND HOMES FOR OVER 4,500 ANIMALS AND ACHIEVED A 96% LIVE RELEASE RATE.

SHELTER HOSPITAL CARE - TO PROVIDE HIGH QUALITY, PERSONALIZED, AND COMPASSIONATE VETERINARY TREATMENT AND MEDICAL REHABILITATION OF SICK AND INJURED ANIMALS IN THE PSPCA'S CARE, A SIGNIFICANT VOLUME OF WHICH ENTER THE SHELTER THROUGH HUMANE LAW ENFORCEMENT. DURING 2019, OVER 2,300 SHELTER ANIMALS WERE TREATED IN THE PSPCA'S SHELTER HOSPITAL.
